

## What's covered?

This course blends theory with case-based practice to support learning. Key topics include:

Day 1:

- Overview of ISO 9001:2015, ISO 14001:2015 and ISO 45001:2018
- Evolution and comparison of ISO 9001:2015, ISO 14001:2015 and ISO 45001:2018
- Process mapping and planning integrated systems
- Risk assessment process and practical case studies
- Implement and operate the management system, including checks, corrective actions and management review processes

Day 2:

- Prepare audit documentation and audit plans
- Build and coordinate an effective audit team
- Conduct audits using appropriate techniques and tools
- Gather and evaluate audit evidence
- Present and report audit findings clearly
- Apply learning through case-based audit scenarios

The content can be customised for In-Company delivery to meet specific organisational needs.
