## What's covered?

This two-day course uses a mix of interactive learning, practical exercises and group work to build audit capability.

Topics include:

### Day One:

- EMS auditing principles and ISO 19011
- Structure and requirements of ISO 14001:2015
- Responsibilities and skills of internal auditors
- Process-based auditing and PDCA methodology
- Conducting document reviews and preparing audit plans
- Practical audit activities and exercises

### Day Two:

- Interviewing techniques and gathering evidence
- Preparing and conducting audits of top management
- Evaluating audit findings, writing nonconformities and generating an audit report
- Opening and closing meetings
- Post-audit follow-up and reporting
- End-of-course quiz and final case study
- Learners participate in practical exercises and case studies throughout, with In-Company delivery offering tailored scenarios and on-site audits.

## Who should participate?

This programme is designed for anyone involved in the auditing, management, or implementation of an Environmental Management System (EMS) that conforms to ISO 14001:2015. It is equally valuable for those who are new to auditing and for experienced auditors who wish to strengthen their skills.

It will benefit individuals who:

- Conduct, plan, or support internal audits of an EMS
- Manage, maintain, or implement ISO 14001:2015 quality systems
- Need to identify and address gaps in system effectiveness to support compliance
- Carry out supplier or external audits on behalf of their organisation

Typical participants include Environmental Auditors and Managers, Engineers, Technicians, Department Managers, Supervisors and Laboratory staff.

### English Language Competency

A good standard of written and spoken English is important to engage effectively with this programme.

## What will I learn?

On successful completion of this course, learners will be able to:

- Plan, conduct, report and follow up internal EMS audits in accordance with ISO 19011
- Evaluate environmental performance and identify nonconformities
- Apply the process-based approach and PDCA cycle to auditing
- Describe the auditor's responsibilities within an EMS
- Use effective techniques for interviewing and gathering objective audit evidence
- Write clear, actionable nonconformity reports

This training focuses on practical audit performance to support measurable environmental improvement.

## What are the entry requirements?

### Entry Requirements

Learners should have prior knowledge of:

- Management systems (Plan-Do-Check-Act (PDCA) cycle, objectives and processes for implementation, monitoring and continual improvement, emphasising the relationship between leadership, planning, operations and review)
- Environmental management concepts (including the interrelationship between improved environmental performance, fulfilling compliance obligations and achieving environmental objectives)
- ISO 14001 structure and terminology

This prior knowledge may be acquired by attending an [ISO 14001:2015 Overview \(EMS\)](#) course or equivalent.

## How will I be assessed?

Learners are **assessed continuously** throughout the course via interactive exercises and engagement in Q&A sessions:

- Role-playing audit scenarios
- Involvement in case study exercises
- Active participation in course discussions
- Tutor-led evaluation of individual contributions

Full attendance and participation are required for successful completion.

## How do we train and support you?

Our training approach is practical, highly interactive and discussion-based, with flexibility to meet organisational needs:

- Pre-training consultation to align with your EMS system (for In-Company courses)
